Health Services

Our health services department provides free rapid HIV testing, STI testing and treatment, and mental health counseling 6 days a week. We provided nearly 2000 tests, along with linkage to care, resource referrals, and education. Our health services department also operates a highly successful health education outreach program in order to provide information on safer sex practices and encourage testing in the local community. Mental health counseling provides services to over 300 clients annually through individual, family, couples, and group therapy along with facilitated wellness activities.

Domestic Violence

The Domestic Violence services program provides free support to victims of domestic violence in the Long Beach LGBTQ community including individual and group counseling, case management, emergency support services, and linkage to emergency shelter. In 2016 the programs provided hundreds of assessments and direct services to more than 125 clients.

Youth Services/MYTE

In 2016, our youth services department served more than 500 unduplicated youth. The cornerstone of the program is our Mentoring Youth Through Empowerment (MYTE) program, a daily after-school drop-in for LGBTQ youth 13-19. This program hosts up to 50 youth daily to drop-in or engage in structured activities like life-skills training, arts workshops, career counseling/resume building, and college/SAT prep. Services provided under this program also included a monthly social and support group for transgender children and families, case management and workforce development support for young adults up to age 29, and training Southern California school districts on best practices in creating inclusive learning environments.
