The Center provides support to inform and connect the lesbian, gay, bisexual, and transgender communities through the following four core service areas: information and education, health and well-being, cultural and social activities, and social justice. In 2012, we provided HIV testing to approximately 1,762 individuals, mental health services to 287 clients and group support to 1,974 individuals. Our front desk provided referrals and assistance to approximately 13,700 individuals.
