It is further understood that no representations, written or oral, other than those contained this Membership Agreement are authorized or binding upon The Center.

Liability for Persons or Property: The Center Long Beach assumes no responsibility for its members.

Membership Guide: The Center Membership Guide describes the benefits of membership, and details important policies, procedures and other items related to the Center.

Acceptance of Terms: The Community Business Partner and its representatives understand that it is entitled to maintain a high level of personal and business integrity and will be held fully responsible for any harm that comes to The Center Long Beach through my misuse of the public trust of its diminishment of the relationship through personal or business actions. The Community Business Partner agrees that as a Community Business Partner, it may not assign to a third party any obligations under this Agreement, or its rights as specified in this Agreement.
