Health Services

The health services department consists of HIV testing, STI screening, diagnosing and treatment, and Transgender Health. Services are available 6 days a week during non-traditional office hours and conducts over 3,200 tests and screening of multi-site specimens. Services include risk reduction counseling, behavior modification conversations, linkage to additional physical and mental health services, referrals to accessing PEP and PrEP as well as linkage to internal programs and services. Transgender Health services include, in addition to testing and screening, direct client linkage to housing, employment development, access to affirming primary care including hormone replacement therapy (HRT), and local gender affirming services and specialized medical care.

Legal Services

The Legal Services Department provides assistance to survivors of domestic violence, sexual assault, hate crimes, stalking, and other violent crimes. The department also manages the organization's free legal clinics and provides name and gender marker change document preparation.
