The Center's Health Services Department provides trauma informed, non-judgmental HIV testing, STI screening, diagnosing and treatment, harm reduction initiatives, and transgender care to more than 1,000 individuals annually. Services are available 5 days per week during non-traditional office hours. Services include risk reduction counseling, behavior modification conversations, linkage to additional physical and mental health services, access to PEP, PrEP, and DoxyPEP, as well as linkage to internal programs and services. Transgender health services include, in addition to testing and screening, direct client linkage to housing, employment development, access to affirming primary care including hormone replacement therapy (HRT), and local gender affirming services and specialized medical care.

The Center's Mental Health Services Department provides individual and group counseling, crisis counseling, shelter placement, and safety planning to approximately 125 victims of domestic violence annually. In addition to direct service work with victims of domestic violence, The Center also provides domestic violence prevention and outreach activities through regular educational workshops for service providers, youth, mental health counselors, and The Center's staff.

The Center's Youth & Family Services Department serves nearly 700 youth, parents, and caregivers annually across diversified programming addressing the post-pandemic educational, emotional, and health needs of at-risk LGBTQ+ youth.
